Listed below are updates of the major construction projects throughout the Village.

PETTIBONE ROAD STREETScape:

Traffic signalization street lighting and landscaping have been completed, which means that the Pettibone Road Southside Streetscape Project is complete.

PETTIBONE ROAD MULTIPLE PURPOSE TRAIL:

Construction is now in progress with the storm drainage, grading and paving of the asphalt trail. We apologize for any inconvenience with the traffic flow. The contractors are trying to keep any inconvenience due to construction to a minimum. Weather permitting, we are hoping to have the trail paved this fall with final restoration spring of 2008.

RICHMOND ROAD SANITARY PHASE II: (North of 7315 Richmond Road to Tryon Road)

Notification from the Cuyahoga County Board of Health to residents involved will be mailed out in the near future informing them of their requirements to connect to the new sewer. Residents will also be invited to attend a meeting at the Village Hall with the Cuyahoga County Board of Health, Village Engineer and officials regarding procedures and information pertaining to connecting the new sanitary sewer and abandoning their existing septic systems. You will be notified in the future.

AUSTIN POWDER DRIVE BRIDGE REPLACEMENT:

The Cuyahoga County Engineering Department will begin construction of the Austin Powder Drive Bridge replacement over Beaver Meadows Creek. The proposed construction will be the replacement of the bridge structure construction of simulated stone walls railing and lights similar to the Pettibone Road Bridge over Tinkers Creek. Construction is to begin this spring with Austin Powder Drive being closed during construction for a period of three months. We will be providing residents with additional information regarding the road closing once this is available to us from the Cuyahoga County Engineer Department.

GEIS COMPANIES:

Diamond Center Parkway is now being paved with completion currently scheduled for the end of November.

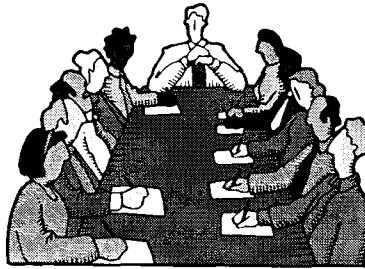

- 2007-10-91 Authorizing Village Engineer to record the Final Plat for the Diamond Business Park subdivision for record purposes only without accepting, at this time, the dedication of the street or other public lands
- 2007-10-92 Authorizing the Mayor to execute and enter into a development agreement with Broad Oak Development LTD and Weston Glenwillow Co. LTD
- 2007-10-93 Accepting the lowest and best bid for paving Diamond Parkway
- 2007-10-94 Establishing a fund to be known as the Diamond Parkway Construction Fund

Since joining our team in April 2006, Michael has been a tremendous asset to the Building Department. He performs skilled inspection work in the enforcement of building, mechanical, plumbing, electrical, zoning, and related codes and regulations governing housing, new building construction, remodeling and repair.

Under his general supervision, the department approves all permits for signs, fences, and new buildings. He also coordinates the Building Department with the Architectural Board of Review and Planning Commission to ensure compliance with all building ordinances.

Glenwillow senior homeowners can benefit from participating in Cuyahoga County's Senior Safety Program this fall. Any senior homeowner 62 years or older, who can meet some income requirements, can apply to take part in this grant program administered through the Housing Division of the County Department of Development.

This program will fund the purchase and professional installation of home safety apparatus such as exterior and interior handrails, bathroom grab bars, electrical outlet replacements, and smoke detectors in senior homes. Also, through this program, seniors will receive an individual assessment and information about trip and fall hazards in their own homes through the County Board of Health.
