#### A COYOTE IS IN YOUR BACKYARD. WHAT SHOULD YOU DO?

Coyotes are common throughout Ohio's 88 counties in both rural and urban settings. There are no wild wolves living in Ohio.

If you do have a coyote on your property, remove all "attractants" to possibly deter the coyote from returning. This includes removing garbage and pet food before nightfall and cleaning up around the grill. Coyotes prey primarily on small mammals such as rabbits and mice. Small pets may also be taken. Keep small dogs and cats inside or stay with them at night when coyotes are most active. Coyotes are curious, but generally fearful of humans. Clap your hands and shout to scare off coyotes that are investigating your yard.

If the coyote visiting your yard seems to lack a fear of humans or is presenting a conflict even after removing attractants from your yard, contact a nuisance trapper. You can locate a trapper near you by calling the Division of Wildlife at 1-800-WILDLIFE (945-3543). Coyotes in rural areas can be controlled through legal hunting and trapping methods. The Village will be performing a complete removal and replacement of the Pettibone & Cochran Intersection starting in early June and is expected to be completed by early August. The Village has contracted with TC Construction Company Inc. to perform the pavement replacement. During the construction, traffic will be maintained at all times except for east bound traffic on Pettibone Road between Austin Powder and Cochran Road. Although Pettibone Road will be open to the railroad tracks, all through traffic east bound will be routed down Austin Powder to Cochran Road. There will be message boards on Pettibone and Cochran Road at least 7 days prior to construction or changing traffic patterns. The Village secured funding through the Ohio Public Works Commission and Cuyahoga County Department of Public Works for a majority of the \$420,000 project cost.

#### PERGL ROAD RECONSTRUCTION PHASE II

The Village will be performing a pavement reconstruction phase II of Pergl Road this summer. The reconstruction will start at Richmond Road and extend approximately 1,300 feet east to the first bend. Specialized Construction will be the contractor for the reconstruction and will begin and complete the work this summer. Residents will have access to their drives at all times during construction. Although some delays may occur during the pavement replacement traffic will be maintained at all times.

#### RICHMOND ROAD RAILROAD CROSSING

In cooperation with the Village of Oakwood, Cleveland Commercial Railroad, and Ohio Rail Development Corporation, the Village will be repairing the railroad crossing at Waste Management's operation facility on Richmond Road this year. The Villages of Oakwood and Glenwillow were awarded \$100,000 from the Cuyahoga County Casino Fund to improve the roadway, drainage and access at the railroad crossing. The Ohio Rail Development Corporation will be providing funding to replace the railroad crossing material and the project will be coordinated to minimize impacts to traffic and access on Richmond Road.





#### WATCH FOR MOTORCYCLES

All motorists are reminded to safely "share the road" with motorcycles and to be extra alert to help keep riders

#### HELMET SMART CAMPAIGN

The Glenwillow Police Department is proud to be participating in the Helmet Smart campaign again this year.

Through this campaign we are encouraging parents to take an active role in their children's safety by encouraging them to wear bike helmets when riding. Officers will issue a "Safety Citation" when they witness a child wearing a safety helmet. Present the Safety Citation, along with the coupon cards, at the Oakwood Village McDonald's for a FREE hamburger small fries and ice cream cone! The bearer of the safety citation is also eligible for several drawings

throughout the summer for a new bicycle from AAA.

#### DRIVE SOBER OR GET PULLED OVER

The Glenwillow Police Department will be participating in the State-wide "Drive Sober or Get Pulled Over" mobilization again this year. This campaign is sponsored by the Ohio Department of Public Safety and will run from **August 17th through September 3rd**. The main purpose of this campaign is to promote public safety and help reduce motor vehicle related fatalities and injuries. According to the National Highway Traffic Safety Administration, 29 people die every day in motor vehicle crashes that involve an alcohol-impaired driver. That is one death every 50 minutes.

#### LEASH LAW

All dogs, regardless of age, breed or size, *must* be on a leash when walking. Dogs are not permitted to run loose upon any public place. Owners must also keep dogs

physically confined or restrained on private property by a leash, tether, adequate fence, supervision or secure enclosure to prevent escape.

#### PARKING REMINDER

There is NO PARKING on any residential street here in the Village. If you are having a party, work done on your home, special event or visitors, please contact the Police Department for parking permission. When permission is granted, be sure to park on the side of the street opposite from the fire hydrants. Parking on both sides of the street makes it difficult for emergency vehicles and school buses

to get through safely.

#### RESIDENTIAL ADDRESSES

The weather has finally taken a turn for the better! While you begin to tackle your outdoor projects, our Public Safety Responders have a request. Please be sure your address is clearly labeled on your mailbox or support post so they are easily seen. This is especially helpful at night or in inclement weather. We appreciate your assistance!

A new SUV was added to the Police Department's fleet of vehicles. This 2018 Ford Explorer is a great addition to the fleet. It is equipped with all necessary equipment and tools for the officers.



#### **BUILDING DEPARTMENT NEWS**

The Building Department is a great resource and reliable tool available to assist homeowners in getting a start towards the construction of a project. Helpful guidelines and permit applications can be found on-line on the Building Department page at <a href="www.glenwillow-oh.gov">www.glenwillow-oh.gov</a>. Providing proper information will expedite the permitting process associated with improvement projects. The guidelines are intended to provide useful information when filing an application for a permit. Experienced staff members available to answer questions.

Permitting begins with filing an application describing the work. In many cases a sketch or drawings are needed to help further describe the scope of the work. The plans are then reviewed to insure that they comply with the Village's codes and ordinances. In certain cases the design may require review by the Architectural Review Board and the site may require review by the Planning Commission. Once those steps are complete a permit can be issued allowing the work to commence. During certain phases of the construction, inspections will be necessary to insure to work is proceeding properly. The plan review and the inspections are part of the professional service provided by the Village as part of the process.

Home and property owners are advised to play an active role in the permitting procedure as they are a legal entity responsible for obtaining the permit even when employing a contractor to perform the work. They are encouraged to review the application and plans with their contractor to insure they understand the complete scope of the work. The home or property owner should sign the application or provide authorization for their representative.

It is vital that an owner research a contractor thoroughly. Resources available for research include the Building Department, the Better Business Bureau, Angie's List, friends and other reliable sources. Have the prospective contractor provide a list of some similar projects they have completed. The Building Department registers and maintains a file of building, electrical, plumbing and heating, ventilating and air conditioning contractors. All contractors are required to provide a certificate of insurance at the time of registration.

Both the permitting process and the contractor registration requirement are intended to provide a level of protection for the home or property owner. Please do not hesitate to contact the Building Department with any questions or concerns.

#### WALK OR RIDE YOUR BIKE ON THE VILLAGE'S NEWEST TRAIL

Get your walking shoes on or put air in your bike tires, because the Tinker's Creek Trail – South is now open. The multi-purpose trail runs from Pettibone Road south to the end of Bond Street along Tinker's Creek. The trail is 10 feet wide with an asphalt surface. This trail opens up a pristine area of Glenwillow that was previously inaccessible to the public. The scenes of the creek and the natural land space, allows you to enjoy this part of nature very close to home.

This trail section is part of the entire Village Trail Plan that will eventually connect the entrance for Bedford Reservation on Richmond Road to the Village southern corporate boundary into Summit County. This trail project also included constructing a Trailhead parking lot complete with handicap accessible parking spaces. When you park in the Trailhead parking, walk east along the trail on Pettibone Road until the connection for the trail, just west of Tinker's Creek. Access to the trail is completely handicap accessible and meets all ADA requirements.

This trail was completed through a partnership with Republic Services and grant funds from Ohio Department of Natural Resources, Clean Ohio Trail Fund.

#### DON'T BE A LITTER BUTT!

Why is Litter a Problem?

When trash (plastic bags, bottles, cigarette butts, plastic cigar tips; etc.) is discarded onto the ground, it washes into storm drains and directly into our waterways untreated. Trash negatively impacts wildlife and migratory birds, poses hazards for fisherman and boaters, and is an eyesore along streets, parks, and waterways in our community.

#### Litter Facts / Did You Know?

• Plastic pieces, cigar tips and cigarette filters are continually at the top of the list of trash found at beach cleanups locally and worldwide (Ocean Conservancy).

· More plastic cigar tips are found on Cleveland beaches than in any of the other Great Lakes Beach Cleanups (Alliance for

the Great Lakes).

• Cigarette filters/butts are NOT biodegradable. The acetate filters take years to decompose, and the toxic chemicals trapped in the filters can leak into aquatic ecosystems, threatening our water resources.

· Plastics break down into tiny pieces called microplastics in water, then release toxic chemicals swallowed by fish, birds,

snakes, and other wildlife.

• It can take 600 years for plastic monofilament fishing line to decompose.

#### What You Can Do:

• Do Not Litter! Lake Erie is our source of drinking water, so we need to do our part to clean up pollution and to educate others not to litter.

 Follow the 3R's—Reduce, Reuse and Recycle wherever possible (Cuyahoga County Solid Waste District is the local recycling resource).

• Use reusable shopping bags instead of single-use plastic bags at the store and recycle bags if the service is available at your grocery store.

· Don't overfill trash cans as litter can blow into the street on windy days.

• If you see illegal dumping, alert the Village's Service or Police Department.

· Organize a storm drain stenciling activity in your neighborhood to educate people that Only Rain goes Down the Storm Drain.

· Volunteer at a local stream, beach or park cleanup event.



## FIRSTENERGY UTILITIES URGE CUSTOMERS TO 'HANG UP, DON'T PAY UP' WHEN SUSPECTED SCAMMERS CALL

Akron, Ohio — With utility scams on the rise, real customers of FirstEnergy (NYSE: FE) utilities are speaking out about their encounters with fraudsters in a mini documentary released today. The video, "Hang Up, Don't Pay Up: When a Scammer Calls," features two business owners contacted by phone scammers impersonating FirstEnergy electric company employees, and provides tips for avoiding scams.

The con artists claimed the businesses had unpaid electric bills and threatened to shut off power if an immediate payment was not made. In both cases, the scammer's phone number was falsified so the caller ID appeared to be a legitimate call, complete with an automated voice menu that mimicked that of their electric company. This common scam is called "caller ID spoofing."

"Scammers can be very convincing and often target those who are most vulnerable, like senior citizens or business owners who rely on electric service to run their business and make a living," said Gary W. Grant, vice president of customer service for FirstEnergy Utilities. "We want others to hear directly from victims of attempted utility scams, in hopes they'll learn how to spot a scam in the future. Most important, if you ever receive a call demanding immediate payment to your electric utility, hang up, don't pay up."

With warmer weather on its way this spring, both residential and business customers should also be on alert for door-to-door visits from scammers who demand immediate payment to avoid service disconnection. Although the scammers work year-round, they are most active in the winter and summer months, when people cannot go without heat or air conditioning.

The "Hang Up, Don't Pay Up" video is featured on FirstEnergy's award-winning Scam and Fraud Information website. This site describes some of the most widespread schemes targeting utility customers, and offers facts and safety reminders that can help customers avoid becoming a victim of these crimes. Customers are urged to keep the following tips in mind to help ensure the safety of their family, property and personal information:

Customers with past-due accounts will receive a written notice of their account status, with instructions on how to avoid disconnection of service.

While FirstEnergy representatives oftentimes make courtesy calls to customers to remind them about an outstanding balance, they would explain how a payment can be made using the established payment options. They will not demand payment over the phone or at a particular physical location.

FirstEnergy field collectors — carrying company-issued photo identification — will offer customers with past-due accounts the opportunity to pay their bill in person before shutting them off.

FirstEnergy does not accept prepaid debit cards or wire transfers as payment, and their representatives will not demand bank or credit card information over the phone.

Customers who suspect a scam should hang up the phone/close the door, and call the local police then FirstEnergy. Never dial the phone number the scammers provide.

FirstEnergy encourages customers to contact them directly using the phone number listed on their website and on the billing statement if they need to verify the status of an electrical account or to confirm the identity of a FirstEnergy employee. When in doubt, always call.

## TIPS FOR YOUR LAWN MOTHER EARTH – TREAT MOM RIGHT

- Mow high at 3 or 4 inches and let clippings lie on the lawn as nature's fertilizer. Save money, time, and prevent over application of nutrients by letting the grass clippings add nitrogen to the soil as nature's fertilizer.
- Don't mulch or compost clippings with annual weed seed heads. Instead, bag it
  up and dispose of it in the trash to prevent more weeds being introduced to
  your lawn.
- Continue to hand pull or spot treat weeds with an organic weed control spray.
- If Japanese beetle grubs are an issue and soil conditions are right, apply Milky Spore to control the population. One application lasts for 10 years.
- Reduce or eliminate pesticides to protect children and animals.

**Did You Know?** Beneficial Nematodes, which are live microscopic organisms that occur naturally in soil, do more than control grubs. They can be used anywhere you have pests. They are also effective on flea and tick larvae, helping keep your pets free of these pests. You can purchase Beneficial Nematodes at any landscaping store.



LICENSE PLATE RENEWAL



When you renew your license plates with the Ohio Bureau of Motor Vehicle, please remember to make sure you tell the clerk or you indicate online, that you live in GLENWILLOW. The Village receives its portion of the license tax fee which is used to repair our roads. Since Glenwillow shares a zip code with Solon, many times the plates are registered incorrectly. There is no difference in the tax if you are listed with Solon or Glenwillow. Please help us earn the money for which we are entitled.




