- Various asphalt road replacements.


Don't forget the branch chipping service runs until the 3rd Monday in October. Take advantage of this free service as you prepare your lawn for fall and winter.

RTA SERVICE IN GLENWILLOW

In June, RTA extended bus 41 Route to include the newer industrial areas of Glenwillow. The bus now goes south on Cochran Road until Pettibone Road and then into Diamond Parkway Business Park. This extension allowed RTA to service the businesses located on Diamond or Victory Parkway. Buses on this route, run about 21 hours per week and service the almost 5,000 employees here in our Village.



In order to encourage ridership at the most affordable cost, RTA has created a program call "Ready to Ride. This program allows for new riders to take a "trial ride" for two weeks for free to see if public transportation will accommodate their work schedules. The best part of this program is that a personal Transit Assistant will help them plan their trip to minimize their ride time from their home.

RTA also has a second program for employers who will offer a pre-tax program for transportation through payroll deductions of using a FSA account.

The last program offered by RTA is a "Guaranteed Ride Home" which will give you a ride home in case of any mid-day emergency. This is a great program to ensure that you get where you need to be in a timely manner at no additional cost to you.

COLLECTION OF RESIDENTIAL GARBAGE AND REFUSE REMINDER (CODIFIED ORDINANCE CHAPTER 952.02)

No recyclable materials, garbage or refuse to be picked up by the Village for disposal shall be placed at the street side or anywhere on the front lawn or in the front driveway for pick up before 5:00 p.m. on the day before pickup, nor left after nightfall on the day of the pick-up.

HALLOWEEN SAFETY TIPS FOR DRIVERS

Halloween is a fun holiday, but because of increased foot traffic and that Trick-or-Treaters are out at night, the potential for automobile related accidents with young pedestrians increases on this night. Streets are literally crawling with all sorts of witches, ghosts, goblins, vampires and all other sorts of costumed people. This makes for added responsibility for drivers to make sure they drive safer than normal.



- Don't use a cell phone or other electronic device while driving on Halloween night.
- Pay extra attention, particularly to crosswalks, intersections and the side of the road.
- Drive below the posted speed limit in residential areas during trick-or-treating hours.
- Do not pass other vehicles that have stopped in the roadway, they could be dropping off children.

PARKING REMINDER

There is **NO PARKING** on any residential street here in the Village. Now that winter is approaching, it is imperative that residents follow this Village



Ordinance. It is important that the Service Dept. be able to have full accessibility to our streets for plowing and salting. If you are having a party, special event or visitors, please contact the Police Department for parking permission. When permission is granted, be sure to park on the side of the street opposite from the fire hydrants. Parking on both sides of the street is prohibited.

ELECTRONIC SPEED SIGNS

Three electric speed signs have been set up at various locations throughout the Village and will rotate on a regular basis. This equipment is intended to alert





drivers of their speed. It is our goal to slow traffic, reduce motor vehicle crashes and keep our Village streets safe.

BACK TO SCHOOL: SHARING THE ROAD SAFELY WITH SCHOOL BUSES

School days bring congestion; Yellow school buses are picking up children; kids on bikes are hurrying to get to school before the bell rings; hurried parents are trying to drop off their kids at school before going to work. It's never more important for drivers to slow down and pay attention than when kids are present, especially before and after school. It is illegal to pass a school bus that is stopped to load or unload children.

- If you're driving behind a school bus, allow a greater following distance than if you were driving behind a car. It will give you more time to stop once the yellow lights start flashing.
- School buses use *yellow* flashing lights to alert motorists that they are preparing to stop to load or unload children. *Red* flashing lights and an extended stop sign signals to motorists that the bus is stopped and children are getting on or off the bus. Remember, traffic *must stop*.
- The area 10 feet around a school bus is the most dangerous for children; stop far enough back to allow them space to safely enter and exit the bus.
- Be alert. Children often are unpredictable and they tend to ignore hazards and take risks.







POLICE BIKE PATROL

The Glenwillow Police Department has now added a Fuji Police Special 29 bike to our patrol fleet.

This bicycle is equipped with front and back digital LED patrol lights. It will primarily be used for community policing, but also to assist officers get to off road locations when needed, whereas; the police bicycle can sneak in through what would ordinarily be considered inaccessible vehicle entry points. Look for Officer Corbets on your residential streets, the bicycle path and at community events.

2018 Paving Programs

In order to maintain good roads throughout the Village, the Pavement Repair Programs will be getting under way in August and will run through the end of the month. The Village will spend almost \$270,000 on both concrete and asphalt programs with \$62,000 being reimbursed by the Cuyahoga County Department of Public Works. Ronyak Paving Inc. will be performing the asphalt repairs and DRS Construction will be doing the concrete repairs. The repair programs will include repairs on several of the side streets and main routes throughout the Village. The work will include replacing crack sealing, concrete slabs, sidewalks, curbing and asphalt pavement.

Pettibone & Cochran Road Intersection Improvement

The intersection improvement was completed in mid-August by TC Construction Company. This intersection is a critical cross roads for the Village which services a majority of the industrial area in the Village. The intersection has been repaired several times over the last few years but it was determined to perform a complete reconstruction this year. The total construction cost of the intersection reconstruction was approximately \$425,000. Fortunately, the Village was able to secure funding from Ohio Public Works and Cuyahoga County Department of Public Works which reduced the Village portion of the construction to approximately \$75,000.

Pergl Road Reconstruction Phase 2

The final phase of the work within the Pergl Road Subdivision, which started in 2011 with the start of the sanitary sewers, has now ended. This project included the reconstruction of the last 1,300 feet of pavement replacement east of Richmond Road. We greatly appreciate the resident's patience during this work which added sewer access to all property owners on Mello, Annetta and Pergl Roads, and reconstructed the pavement as well.

Richmond Road Railroad Crossing Improvement

This project will include the replacement of the railroad crossing and the pavement leading up to the crossing along with some drainage improvements. We are scheduled to begin construction in early October and complete by the end of the year. This project included coordination and funding from the Village of Glenwillow, Village of Oakwood, Cleveland Commercial Railroad (CCR), Cuyahoga County Department of Development (CCDD) and the Ohio Rail Development Corporation (ORDC). The estimated cost of construction will be approximately \$190,000. Of the estimated construction cost, the Village(s) have secured \$100,000 from CCDD, \$70,000 from ORDC and \$4,000 from CCR.

NEW INDUSTRIAL PROJECT BREAKS GROUND

On June 7, Westminster Capital investors in Lake Forest, Illinois held a groundbreaking for a state-of-the-art industrial property on 30 acres on Victory Parkway in the Diamond Business Center Park. Westminster will own the new building, called Victory Commerce Center, and hopes to lease it to one or two national tenants. Plans approved for the building call for a 434,000 square feet facility with 32-foot clear heights, 52 docks, LED lighting and parking. The building is expected to be completed in 1st quarter of 2019. At this time, the owners and brokers of the building are working to secure the tenant(s) for the facility.



Village Council and the Solon School Board approved a business incentive package including a Community Reinvestment Tax Abatement to secure this project for our community. We are pleased that Westminster Capital chose to build this new Class A building and to invest in our community to help us continue the industrial development in the Village.

ENERGY EFFICIENCY FUNDING PROGRAMS

NOPEC is an organization that works to provide a competitive environment of energy costs for both residential and small business consumers. They work to bring reliable, stable and lower energy cost to their customers.

They are offering programs to help small businesses save on energy costs, the STEP Program and the Property Assessed Clean Energy Financing (PACE) Program.

Here is a summary of both these programs:

In the STEP Program, NOPEC will provide low cost loans for projects in the range between \$5,000 and \$100,000 at a fixed interest rate of 3%. They also offer long-term financing. Eligible projects are:

Energy Efficiency Improvements (HVAC, windows, doors, roof, lighting)

- Geothermal Energy projects
- Solar-photovoltaic (roof-top and ground-mounted solar arrays)
- Solar-thermal Water Heating Systems

The PACA Program allows a commercial property owner to finance energy efficiency and renewable energy improvement projects through assessments on their real property tax bills. Energy efficient improvements can increase the value of the property. The assessment stays with the property if it is sold before the assessment is paid.

Eligible Projects for the PACE Program are:

- Energy Efficiency Improvements(HVAC, windows, doors, roof, lighting)
- Geothermal Energy projects
- Wind Energy projects
- Solar-photovoltaic (roof-top and ground-mounted solar arrays)
- Solar-thermal Water Heating Systems
- Biomass Energy or Gasification projects
