Mayor Cegelka reported; Village Hall is still closed to the public at this time. The employees, and staff are following the protocols established by the governor and the CDC. They are practicing social distancing while at work and frequently touched surfaces and equipment are being sanitized on a daily basis.

Calls to Village are Hall are being answered during normal business hours by Lori.

A newsletter will be going out with updates and the community programs we currently have in place. (mulch, branch chipping etc.)

There have been no positive cases of COVID-19 at Stratford Commons or in the Village of Glenwillow. Chief Curtin has been making weekly welfare calls to the seniors in the Village to offer assistance with picking up groceries or medication.

## FINANCE DIRECTOR JOHN VERES:

- Finance Director John Veres reported; he is continuing to come into the office on Fridays to be able to meet with the Mayor and Jeremy while practicing social distancing.
- John and the Mayor are monitoring programs for local communities. So far there are none.
- Mayor Cegelka reported; he and John are continually monitoring the 25 taxpayers that account for approximately 90% of the revenue that comes in from the businesses.

#### LAW DIRECTOR MARK MARONG:

- Law Director Mark Marong explained all items on the agenda this evening; item 2 is the annual codification. Items 3,4 & 5 are updates to the Village code in compliance with the First Families Corona Virus Act. Items 6, 7 & 8 are annual Job Creation Grants to compliant businesses. Item 9 confirms approval for Joe Kulis to place certain parcels in a CUAV Tax District. Item 1 is the annual road salt participation contract. Item 11 is a license agreement with 7730 Bond, LLC allowing contractors to use Village property with certain restrictions and guidelines.
- The band contracts will be on the May 6<sup>th</sup> Council Meeting Agenda.

#### SERVICE DIRECTOR SAM SCAFFIDE:

- Sam Scaffide Service Director reported; all reports were submitted in the Mayor's report.
- Republic Services has put new guidelines out for garbage pickup. Information was given to residents and will be posted in the next newsletter.
- The flowers and flower baskets for spring/summer planting have been ordered.
- Barb DiBacco questioned if the trails ae being maintained at this time; Sam Scaffide responded; the Service Department is maintaining the trails and making sure they are free of debris. A large tree recently came down on one the trails due to the recent high winds and the department was quick to remove it. The parks and playgrounds are closed at this time.

#### ECONOMIC DEVELOPMENT DIRECTOR JEREMY ROWAN:

- Economic Development Director Jeremy Rowan commented; GED, NOCO and Southern Glazers are the 3 active Job Creation Grants. All have met their payroll withholding requirements.
- Jeremy has reached out to the businesses via email and phone to get information to them regarding resources and Federal Aid Programs available. He will continue to pass resources on as they become available.
- Jeff Adie questioned if any companies are actively pursuing any of the grants that are available for businesses. Jeremy replied; he has not heard or been notified of any business that has applied or currently pursuing any of business grants out there.
