Moving forward we do have some exciting projects planned for this year. The first is the moving of the train depot on Pettibone Road. The depot is currently owned by Midwest Railway and Preservation Society. It is one of the oldest structures in the Village. Midwest Railway Preservation Society did not want to tear it down and neither do we. The building will be moved across the tracks onto Village property at the new Pettibone Road Park. Midwest Railway Preservation Society will be the lead on this exciting project and is going to use its wealth of volunteers and contractors to move the depot to the new location and has agreed to sell the depot to the Village for \$1.00. Once moved, we will begin to look at restoring the building. The Village was awarded \$50,000 from the Cuyahoga County Casino Fund to help with improvements. We felt a strong need to preserve a piece of history of the Village, while maintaining its uniqueness. In this newsletter you will find an article about the history of Falls Junction Train Depot and the Railroad.

Other happenings planned at the Pettibone Road Park is the installation of public restrooms. This will be a great addition to the park area. The parking lot and picnic shelter were built in 2018. Other amenities planned for the park include a gazebo and Veterans Memorial honoring all five branches of our country's military and a walking path through the park area.

## HELPING HANDS

## COMMUNITY GARDENS

The Village has developed a Community Garden for residents who would like to plant a vegetable garden over the spring and summer. The Service Department will see that each plot of land is tilled initially and then each participating resident will be responsible for planting, watering, weeding and harvesting the crops. The Village will supply a water source near the garden area. The gardens are located at 28875 Pettibone Road.

## RESIDENTIAL KNOX BOX PROGRAM

This program is offered as a courtesy for our senior citizens and disabled adults. The Knox Box is positioned on the entrance door of the home that is intended for normal access. The key for this entrance door is stored inside the locked Knox Box. Oakwood Village Fire Department maintains the only key to the Knox Box which opens the secure box.

# SENIOR TRANSPORTATION SERVICES



The Senior Transportation Program with Oakwood Village shall include transportation services from Oakwood to the seniors in Glenwillow for medical appointments, shopping, personal business, recreation, nutrition, religious events and any other social events.

## Who can use the Oakwood Village Van?

Seniors 60 years or older and physically challenged residents who live in the Village of Glenwillow.

## How do you reserve your ride for medical appointments?

**Reservations for medical appointments should be made at least ONE WEEK IN ADVANCE between 9:00 a.m. and 5:00 p.m., Monday through Friday by calling 232-9988.** If you are scheduled to have a procedure requiring the use of anesthesia, please make other arrangements. The van is not equipped and drivers are not trained to handle emergencies that may arise during transport. Please note that the van is not available on Wednesday afternoons.

**Suggested appointment times are 9:00 a.m. through 2:00 p.m.** Return trips are not available after 4:00 p.m. In this situation, please make other arrangements for return transportation. **(Rides are only being offered Tuesday and Thursdays until further notice)**

The following information is required to reserve a ride:

- Name, address and telephone number
- Destination address
- Date and time of appointment
- Physician's name and phone no.

## How do you reserve your ride for other appointments?

Reservations for banking, prescription pick-ups, grocery shopping, social service agencies, library, beauty shops, cinema, etc., should be made 24 HOURS IN ADVANCE by calling 232-9988. ***Please note that the van is not available on Wednesday afternoons.***

**Suggested times are 9:00 a.m. through 2:00 p.m.** Return trips are not available after 4:00 p.m. In this situation, please make other arrangements.

## How do you cancel your trip?

Please let us know within 24 hours if you must cancel a scheduled appointment.

**Van Fare:** There will be a charge of \$1.00 per ride (round trip).

# FREE CURBSIDE BRANCH CHIPPING SERVICE

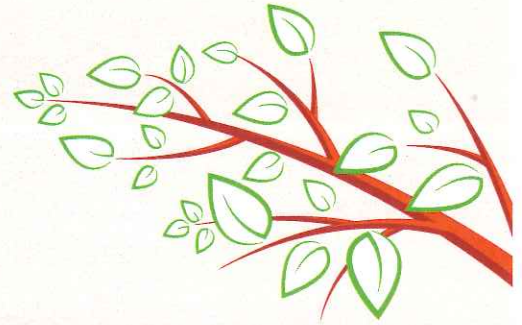
WILL TAKE PLACE THE THIRD MONDAY OF EVERY MONTH STARTING IN MAY!

Please have your tree trimmings set out no later than 8:00AM on the scheduled Monday mornings.

## PLEASE NOTE THE REQUIREMENTS FOR THE CHIPPER:

- No Stumps – No Roots – No Foreign Matter
- Nothing larger than 7 inches in diameter
- Cut “Y” Shaped Branches in Two
- No Firewood – No logs less than 4 feet long
- Separate small from large branches
- Face “Cut End” of branches towards the road
- Free of Poison Ivy

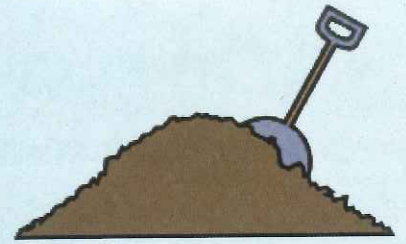

## ATTORNEY GENERAL YOST WARNS OF AN OUTBREAK OF SCAMS RELATED TO CORONAVIRUS

(COLUMBUS, Ohio) — Fear and uncertainty surrounding the coronavirus pandemic could give rise to an outbreak of scams, Ohio Attorney General Dave Yost warns.

“COVID-19 is not the only thing we have to protect ourselves against,” Yost said. “Thieves and crooks prey on fear and uncertainty. Ohioans need to inoculate themselves against an outbreak of scams with knowledge and good practices.”

Yost encourages Ohioans to follow these tips to avoid coronavirus-related scams:

- Watch out for emails claiming to be from the Centers for Disease Control and Prevention (CDC) or other expert sources with special advice or information about the coronavirus. Legitimate information is available for free on the CDC's website.
- Ignore online advertisements promoting cures for the coronavirus. According to the Federal Trade Commission, “There currently are no vaccines, pills, lotions, lozenges or other prescription or over-the-counter products available to treat or cure Coronavirus disease 2019 (COVID-19) online or in stores.”
- Research nonprofit organizations and crowdfunding campaigns before donating. A database of registered charities is available on the Ohio Attorney General's website. Avoid groups that pressure you into donating and never donate via cash, gift cards, wire transfer or prepaid money card. These are the preferred payment methods of scammers.
- Be cautious of anyone going door to door offering coronavirus testing or temperature readings and requesting personal information. Call law enforcement immediately if you see a suspicious person. Never let strangers into your home.
- Beware of emails and other attempts to “phish” for your personal, financial and medical information. When in doubt, do not share. If the source claims to be your bank or a government agency, confirm they are legitimate by calling the organization at a phone number you have verified.
- Amid discussions of providing working families with government checks, know that nothing has been formalized yet. For more information, visit the Federal Trade Commission website and stay tuned for updates from reliable news sources.
- When online, avoid clicking on unknown links or pop-ups and never download any suspicious email attachment. Doing so could infect your devices with malicious software designed to steal your personal information or lock your computer until you pay a ransom.

## LEASH LAW

All dogs, regardless of age, breed or size, must be on a leash when walking. Dogs are not permitted to run loose upon any public place. # FALLS JUNCTION DEPOT

Falls Junction station is located 16.4 miles from downtown Cleveland on the Wheeling and Lake Erie Railway. It served the railroad and Glenwillow's surrounding area for 91 years. Let's take a ride on a horse drawn wagon to the depot during the late 19th and early 20th century, we have a train to catch.

On a typical day one could find folks waiting for a passenger train on the depot's red cinder brick platform. People would squint their eyes looking down the polished shiny rails and checking the depot's train-order signal for signs of an oncoming train. In addition, they could also check the train sign board, which contained a listing of every train due to stop at the station. On chilly days riders took shelter and warmth inside the depot's waiting room, where they would be greeted by the station agent.

The depot's station agent acted as the railroad's representative, serving Glenwillow's needs in any way possible. They had many daily duties such as selling tickets, unloading or loading inbound and outbound baggage and mail from the baggage car, and stoking the coal-fired stove during the winter months. Their office located in the depot's bay window, contained a wooden desk adorned with telegraph instruments, paperwork, and a lever that controlled the train-order signal, which signaled trains to stop at the station.

Glenwillow townspeople also gathered at the depot for comradery.

Farmers from the outlying area, additionally hauled their goods such as fresh produce, milk, and sometimes cattle, to the depot. These commodities would be shipped by rail to railroad terminals like Cleveland, and Canton destined for the market.

The railroad line which intersects the Village of Glenwillow, was originally owned and constructed by the Connotton Valley Railway Company. The Connotton Valley was formed on October 25, 1880 by consolidation of two predecessor railroad companies called the Connotton Valley Railroad and the Connotton Northern Railway. It was a "coal hauling" 118 mile three-foot (the distance between both rails), commonly referred to as narrow gauge, mainline stretching from Cleveland to the Connotton Creek in Bowerston, Ohio. Construction of the line began northward and was opened to downtown Bedford Public Square on July 1, 1881. The line into Cleveland was opened in January 1882.

The coal fields the railroad tapped into in Stark and Carroll counties, were the Connotton, and Osaburg coal seams. In its first year of operation, the Connotton Valley moved over 100,000 tons of coal to their docks in Cleveland destined for the lake trade and mills. The Village of Glenwillow did not exist when this railway began operations in 1882. The land which makes up the Village was once a part of Solon and Twinsburg Townships.

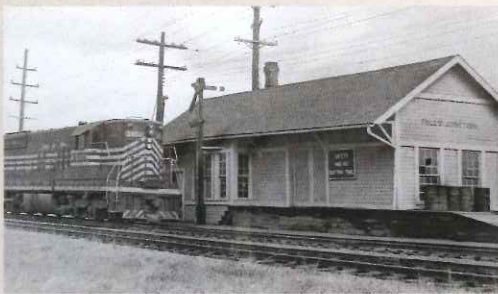


Originally, the Falls Junction station was called "South Solon," since it was located in Solon Township. A depot building was erected near Old Cochran Road (Austin Powder Dr.). However, this was a different, smaller structure than the current standing depot. The surrounding area farmers made South Solon a busy place. It became so busy that a sidetrack was built in 1883.

Eventually, the Connotton Valley Railway was stricken with financial troubles, and fell into receivership on January 20, 1884. The company was sold at foreclosure to the Massachusetts Hiram A. Blood Syndicate on June 23, 1885 and reorganized as the Cleveland and Canton Railroad Company on July 2. The Cleveland and Canton would later be consolidated further as the Cleveland, Canton and Southern. After the company defaulted on its bonds and fell into receivership again in 1893, it was purchased by the Wheeling and Lake Erie Railway on August 5, 1899.

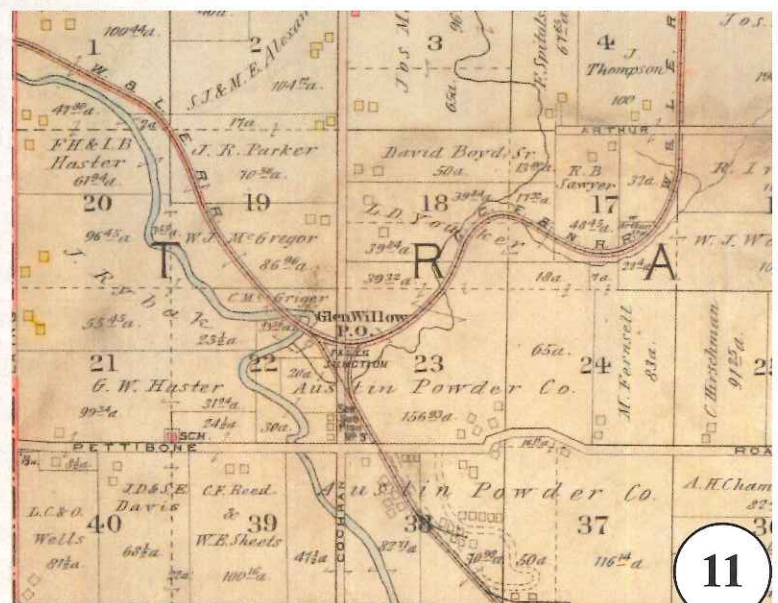
The name Falls Junction came into the picture on August 3, 1888 when the Blood Syndicate incorporated the Cleveland, Chagrin Falls and Northern Railroad. A 3.04-mile branch line was constructed from the Cleveland and Canton mainline at Austin Powder Dr., north to downtown Solon, connecting with the 5.155-mile Chagrin Falls and Southern Railroad. The connection was completed on March 28, 1889. This created a junction between the two railroads named Falls (Chagrin Falls) Junction. The South Solon station was thus renamed as this.

On January 14, 1892 Richard T. Coleman, then President of the Austin Powder Company, purchased about 482 acres of Dudley Pettibone's land. Later that year, the Austin Powder Company accumulated 1,000 acres of land in total. They used this land to relocate their black-powder mill from the southern outskirts of Cleveland in Newburgh Township.

Austin Powder's much larger and modern facility containing about 50 different buildings opened in 1893. A company town was built for their employees west of the railroad tracks. It consisted of 24 in total single and double story houses, a hotel, church, school, and a general store with a partition inside separating the newly established "Glenwillow" Post Office in the north end of the building.

To better accommodate the Austin Powder Co., the Falls Junction depot was moved south from the junction to its current location. Austin Powder had purchased the property parcel on which the building is located. In 1905, the original Connotton Valley Railway depot building was demolished and replaced with a new larger structure (the current standing depot building) by the Wheeling and Lake Erie.

With the rise of personal automobiles, and the unprofitability of passenger trains, W&LE passenger service to Glenwillow was discontinued on July 17, 1938. The depot continued only as a freight station for the Austin Powder Co. until 1972 when it was retired.
