## NO SOLICITATION

The best way to keep solicitors and unwanted guests from knocking on your door is to display "No Soliciting" signs provided by NOPEC. By posting a sign, you are exercising your right to refuse uninvited visitors. Village code section 741.04 prohibits solicitation of any residence with a "No Soliciting" sign posted. The Village is currently partnered with NOPEC to participate in a No Solicitation program. You do not have to be NOPEC customer to participate in this program. #### Household materials accepted

- Oil or solvent-based paint, sealers, primers, or coatings (aerosols or liquids)
- Varnishes, polyurethanes, shellacs
- Paint thinner, mineral spirits, turpentine
- Pesticides, herbicides, fungicides
- Caustic household cleaners
- Pool chemicals
- Automotive fluids, motor oil, car batteries
- Adhesives, roof tar, driveway sealer
- Kerosene, gasoline, lighter fluid

#### Materials NOT accepted at this collection

- Latex paint
- Explosives, gun powder, ammunition, flares
- Medical waste, pharmaceuticals, medicine, sharps
- Radioactive waste (i.e. smoke detectors)
- Appliances, electronics
- Fluorescent bulbs
- Business or commercial waste

# DISCOUNT PROGRAMS



Cleveland Water offers two discount programs to assist income-eligible customers with the cost of their water bill. Both programs provide residents who qualify with the option to receive discounted rates concerning their water bill.

## The Homestead Discount

The Homestead Discount Program offers a lower fixed charge and consumption rate. To qualify for the Homestead Discount Program, customers must meet the following criteria:

- Must be 65 years or older, or totally and permanently disabled;
- Must own and live at the property; and
- Must have current income at or below the current income guidelines.

## Enrollment

- To enroll in the Homestead Discount Program, customers must complete and submit an application. Enrollment is valid for 3 years for new and current enrollees, after which a renewal application is required. To download an application go to [www.clevelandwater.com](http://www.clevelandwater.com) or you can pick an application up at Village Hall.
- Reminders will be sent to customers when renewal is required.

## Water Affordability Program

- The Water Affordability Program offers a 40% discount on all standard water charges. This includes both the monthly fixed charge and the consumption charge. To qualify for the program, a customer must own and live at the applying service address and have a total household income at or below the current income guidelines.

Replace Smoke Alarms Every 10 Years



When we set our clocks **ahead an hour in Spring** and **back an hour in fall**, we should also change the batteries in our smoke detectors and other safety equipment.

1. Remove the smoke alarm from the wall or ceiling.
2. Look at the back of the alarm for the date of manufacture.
3. Smoke alarms should be replaced 10 years from the date of manufacture and batteries changed when the time changes.
4. Put the alarm back on the ceiling or wall if it is less than 10 years old.

# SENIOR TRANSPORTATION SERVICES

The Senior Transportation Program with Oakwood Village shall include transportation services from Oakwood to the seniors in Glenwillow for medical appointments, shopping, personal business, recreation, nutrition, religious events and any other social events.



## Who can use the Oakwood Village Van?

Seniors 60 years or older and physically challenged residents who live in the Village of Glenwillow.

## How do you reserve your ride for medical appointments?

Reservations for medical appointments should be made at least **ONE WEEK IN ADVANCE** between 9:00 a.m. and 5:00 p.m., Monday through Friday by calling 232-9988. If you are scheduled to have a procedure requiring the use of anesthesia, please make other arrangements. The van is not equipped and drivers are not trained to handle emergencies that may arise during transport. Please note that the van is not available on Wednesday afternoons.

**Suggested appointment times are 9:00 a.m. through 2:00 p.m.** Return trips are not available after 4:00 p.m. In this situation, please make other arrangements for return transportation.

The following information is required to reserve a ride:

- Name, address and telephone number
- Date and time of appointment
- Destination address
- Physician's name and phone no.

## How do you reserve your ride for other appointments?

Reservations for banking, prescription pick-ups, grocery shopping, social service agencies, library, beauty shops, cinema, etc., should be made **24 HOURS IN ADVANCE** by calling 440-232-9988. **Please note that the van is not available on Wednesday afternoons.**

**Suggested times are 9:00 a.m. through 2:00 p.m.** Return trips are not available after 4:00 p.m. In this situation, please make other arrangements.

## How do you cancel your trip?

Please let us know within 24 hours if you must cancel a scheduled appointment.

**Van Fare:** There will be a charge of \$1.00 per ride (round trip).

## LIFELINE SYSTEMS

The Village has a contract with Lifeline Systems for 15 monthly services for our senior citizen residents. This service allows for residents to call for assistance with the push of a button worn around your neck or as a bracelet. # RESIDENTIAL KNOX BOX PROGRAM

The Residential Knox Box program entails the provision of a metal box that is secured with a key lock. The Oakwood Village Fire Department maintains the only key to the Knox Box which opens the secure box. The Knox Box is positioned on the entrance door of the home that is intended for normal access. The key for this entrance door is stored inside the locked Knox Box. A sticker to identify the presence of the Knox Box is placed on doors and/or windows of the home to notify emergency responders that a Knox Box is in use.

## Eligibility to Participate in the Knox Box Program

- Resident of Glenwillow
- Permanent or temporary medical disability
- Spend all or a substantial majority of day alone at home
- Agree to participate in program
- Sign application and release form
- Participation of eligible residents is at no charge

Non-eligible residents may obtain a Knox Box by paying a \$150.00 refundable deposit to the Oakwood Village Fire Department.

The Village of Glenwillow will be offering free curbside branch chipping collection to the residents of Glenwillow the third Monday of every month from May through October.

Please have your tree trimmings set out no later than 8:00AM on the scheduled Monday mornings.

### PLEASE NOTE THE REQUIREMENTS FOR THE CHIPPER:

No Stumps – No Roots – No Foreign Matter

Nothing larger than 7 inches in diameter

Cut “Y” shaped branches in two

No Firewood – No logs less than 4 feet long

Separate small from large branches

Face “Cut End” of branches towards the road

If you are having work done on your home, having a party, special event or visitors, *please contact the Police Department for parking permission*. When permission is granted, be sure to park on the side of the street opposite from the fire hydrants. Parking on both sides of the street is prohibited.


## REMINDER.... there is no parking

- On the sidewalk, curb or lawn area
- In front of a private driveway
- Within ten (10) feet of a fire hydrant
- Within thirty (30) feet of a stop sign
- Within one (1) foot of another parked vehicle

Officers routinely patrol our residential streets. During patrols, officers closely monitor the streets for parking violations. Officers will enforce our Village parking ordinances by issuing a written warning to first time offenders, and citations to repeat offenders.

## FREE MULCH PROGRAM

Once again Republic Services, the Village's waste hauler will be generously donating free mulch for residents' yards this spring. The mulch will be available in May. Each resident will receive up to 1 ½ yards of mulch to spread in landscaped areas of their yard.

## USE OF VILLAGE TRUCK

Spring cleaning the attic, garage or shed? Or maybe you are decluttering your basement. The Village truck is available to the residents of Glenwillow from April 1st until October 31st each year free of charge for the collection of trash. The Service Department will arrange a time and place to drop the truck off on your property and a time to pick up. The use of the truck is limited to the **collection of trash only**. **Items that cannot be loaded on the truck are: grass clippings, tree trunk/roots, bags of leaves, aerosol cans, paint and paint cans.** This truck is not allowed for construction debris, which is the responsibility of a contractor.

# DISPOSE OF UNNEEDED MEDICATIONS

In addition to keeping these substances out of our water supply, safe disposal of unneeded medication helps to keep drugs out of the hands of people who might abuse them.

The Village has a secure permanent drop box where prescriptions and over-the-counter medications can be placed for safe disposal.

The box is located inside the lobby at Village Hall 29555 Pettibone Road

## RECYCLING REMINDERS

Recycling contamination is a major problem. Contamination happens when well-intended recyclers mistakenly put the wrong items into their recycling. It can wreak havoc on the recycling process throughout the world.

The best way to avoid recycling contamination in your curbside recycling is to recycle only these five core items:

- **CANS**: Empty and rinse.
- **CARTONS**: Empty and rinse. Replace the cap -- it's too small to be recycled by itself!
- **GLASS BOTTLES & JARS**: Empty and rinse.
- **PAPER & BOXES**: Flatten cardboard items, like cereal boxes, to save space.
- **PLASTIC BOTTLES & JUGS**: Empty and rinse. Replace the cap.

Place these items loose – not bagged – in your recycling bin. All items should be empty, clean and dry. Plastic bottles and jugs include items with an opening or neck that is narrower than the body.

Cuyahoga County's ReadyNotify emergency notification system is in the final stages of transitioning to a new vendor platform, called CodeRED. ReadyNotify is Cuyahoga County's emergency notification system. The system is used by the County and any participating communities to send messages concerning emergencies, weather events, and community news. As part of this transition, citizens currently subscribed to ReadyNotify are encouraged to re-register in the upgraded system by visiting [readynotify.us](http://readynotify.us) or downloading the CodeRED Mobile Alert App, available at the iTunes Store or GooglePlay.

### **What Type of Notifications Will I receive?**

You can expect to receive notifications about:

- Emergency Events
- Cuyahoga County Government News
- Cuyahoga County Building Closures
- Water Boil Alerts
- Safety Messages
- Other Information

The Village may also activate CodeRED to send GENERAL notifications to registered subscribers to communicate non-life-threatening safety matters, such as planned road closures, water main repairs, water and power service interruptions, etc. By selecting the box for GENERAL alerts, you can also receive these types of notifications.

There is no charge to register for or use of CodeRED and your personal information will be kept confidential. Registering for CodeRED is quick and easy:

### **Things to Know About CodeRED**

- CodeRED delivers notifications by phone, email, text, and/or mobile alerts
- CodeRED is compatible with TDD/TTY devices for those with hearing impairments
- Individuals and businesses may add as many phone numbers, email and texts numbers as they choose

### **CodeRED Mobile Alert App**

Residents and visitors can now receive enhanced public safety alerts no matter where you are located via the CodeRED Mobile Alert app, a free public safety app for both Android and iPhone users. The CodeRED Mobile Alert app delivers community and emergency alerts to individuals targeted within an impacted geographical area. The app enables you to receive timely notifications when you are on the road, away from home.

If you are currently a CodeRED subscriber that has already registered your mobile phone to get notifications, you will continue to receive calls. However, if you download the app, you will also be able to get alerts to your smartphone anywhere in the country, including Hawaii, Puerto Rico, and Alaska.

# DEALING WITH ROBOCALLS



The Cuyahoga County Department of Consumer Affairs and the Scam Squad have received numerous reports of robocalls of all types. Some residents are reporting repeated, abusive calls – for example, 15 to 20 calls a day, just minutes apart. Follow these tips to ease your frustration with these pesky calls:

- **Do not pick up calls from unknown numbers.** Let calls from unknown numbers go to voicemail so you can screen them. Answering a robocall or scam call just gets you more unwanted calls.
- **If you pick up by mistake, hang up.** Don't ask robocallers to stop calling or interact with them at all. Interacting or following prompts to talk to someone only confirms your number is working and that they have reached a live person. This can lead to more scam calls.
- **Be wary of calls from numbers that resemble yours.** Robocallers may try to trick you into picking up by using "spoofed numbers" that fake your area code/exchange or duplicate your phone number. Resist the urge to answer the calls out of curiosity.
- **DO NOT automatically call back numbers that called you.** If the unknown caller did not leave a message, treat it like a scam call.
- **Don't be scared into paying or sharing personal info.** Many robocalls are designed to scare you into thinking you are under investigation, owe money to the IRS or another government agency, or have run afoul of the courts. No legitimate agency will tell you of an impending arrest or court action by phone. Treat all unexpected calls seeking personal information or money as suspicious.
- **If calls are persistent:** Opt for peace and quiet and turn the ringer on your phone off for a day or two (just leave yourself a reminder to turn it back on.) Abusive repeat calls tend to subside after a couple days.
- **Report robocalls.** File a complaint with the Scam Squad **216-443-SCAM (7226)**.

## FALL LEAF COLLECTION

**Reminder of the weekly leaf collection service the Village offers that begins in October and continues through November weather permitting.**

Residents are asked to follow a few simple guidelines to help keep this service cost-effective and efficient for all:

- Leaves must be out no later than 7:30 AM on Mondays, in order to guarantee collection in that round.
- Leaves should be placed on the tree lawn in neatly stacked piles. (grass area within 10 feet of the pavement edge)
- Where a ditch exists along the pavement edge, leaves should be placed **ON THE STREET SIDE** of the ditch rather than behind or in the ditch.
- Piles **must** be free of stumps, branches, grass clippings and other yard waste such as, briars, vines, and anything with thorns to be collected.

The Service Department will pick up only those materials that conform to the above guidelines.
