Mayor Cegelka commented; The Planning Commission has had a vacancy that needed filled. He announced the appointment of resident Neil DeCarlo to the Board. Neil has lived on Pergl Road for 11 years. Neil was in attendance

and introduced his wife Beth and their children. Neil's mother, Joanne Altizer was in attendance, and also owns a home in the Village. She grew up in Glenwillow and now resides in Macedonia. Neil is honored and excited to be part of the Planning Commission.

LAW DIRECTOR MARK MARONG:

Law Director Mark Marong explained the items on the agenda this evening.

A donation agreement is on the agenda with Broad Oak Development for the 10-acre parcel on the corner of Diamond Parkway and Pettibone. Geis has graciously agreed to donate this parcel to the Village at no cost.

There is a settlement agreement, waiver and release between the Guru Gobind Singh Sikh Society and the Village. There is also a purchase and sale agreement with West Creek Conservancy for the 3 parcels on the corner of Richmond Rd. and Pettibone Rd.

VILLAGE ENGINEER MIKE HENRY:

Engineer Mike Henry reported; his report was submitted in the Mayor's report.

The change order for R.E. Warner on the agenda this evening is for the remodeling of Lori's office and adding another workstation for Economic Development Director Jeremy Rowan.

Work to install the restroom near the Community Gardens will begin this week.

CHIEF GREG CURTIN:

Chief Greg Curtin commented; the Cochran Road improvement project has gone smooth with the closing of Austin Powder Dr.

Decals will soon be added to the new golf cart that was added to the fleet of vehicles.

There were no problems on the Fourth of July and only one complaint.

The department is losing three part time officers. All three are leaving to go work for Orange Village Police Department.

Oakwood Fire Department will be at the summer concerts on standby in case they are needed.

SERVICE DIRECTOR SAM SCAFFIDE:

Service Director Sam Scaffide reported; the siding on the annex garage is getting replaced. This is a needed improvement that will also make it more aesthetically pleasing. It will remain white with green trim.

The garage behind the Building Department is also getting resided along with a roof replacement. The roof will then match Village Hall and the Building Department.

The Department has been busy maintaining landscaping and maintaining the public areas throughout the Village. Up-lighting is being installed next week around Village Hall.

Sam reported; Mayor Yates of Twinsburg resigned to take a City Managers job in Florida. Therefore, as Council President Sam was sworn in as Mayor of Twinsburg on July 1st, as part-time. He will remain as Service Director here and cut back his hours while shifting some of the responsibilities to the Assistant Service Director Daryl Schultz. Sam will have to run on the on the ballot in November as Mayor. If elected, he will revisit his responsibilities as Service Director.

COUNCIL COMMENTS:
