Honoring the Past – Welcoming the Future Dear Residents,

Happy New Year to you and your families! With winter upon us and spring around the corner I like to stop and reflect on all we accomplished last year and look forward to the projects we have planned for this year. Some highlights of our accomplishments in 2022 were:

• Installation of a restroom and pavilion with underground utilities at the Community Garden area located on Pettibone Road.

Completed ADA improvements to Village Hall.

• Received \$38,565 in grant money for the Healthy Urban Tree Canopy Program from the County Planning Commission. We were able to plant 117 trees throughout the Village.

 Made improvements to the Tinker's Creek Trail including construction of a new outlook.

· Improvements to Cochran Road

• Phase I of the Pettibone Road Sanitary Sewer Project was completed. Phase II will begin this spring to connect the last section of the Village to sanitary sewers.

Mayor Mark A. Cegelka

The end of 2022 brought on some changes for our Staff. After eleven years of service, Service Director Sam Scaffide has set his sights on becoming Mayor of the City of Twinsburg. After seven years of service in the Village, Building Official Bob Rodic has decided to continue his career full-time in another municipality. Both Sam and Bob have been an integral part of our Village Staff and their contributions and commitment to the Village are to be commended and will not be forgotten. Good luck to both of them as they start a new chapter. We would like to introduce you to our newest Staff members, Service Director Bob Girardi, and Building Commissioner Braden Thomas. Both have previous municipal experience, and we are happy to have them as part of our team.

Projects my Staff and I have been working on for 2023 are: The plans for the new Service Center Complex that will be located at 28555 Pettibone Road are progressing. After interviewing four contractors in July, the Village contracted with Ruhlin for the construction of the facility. Ruhlin along with the Architect R.E. Warner & Associates have finalized the design of the facility and coordinated the site plan. A construction site trailer is on site and utility coordination has begun. The new 20,500 sq. ft. facility will be able to house all of our service equipment and vehicles out of the elements as well as a more functional area for maintenance of vehicles. The facility will also be home to the Service Department and Building Department offices. Watch for updates as the project progresses. We hope for completion by the end of the year!

The design for the Veteran's Memorial has been finalized. The Village applied for and received \$50k from the County from the Community Development Supplemental Grant (CDSG) Program for the project. Phase I of the project consists of grading the site, adding pavers and a sidewalk and a monument with an eternal fame. This portion of the project is expected to be completed this fall.

Restoration of the Falls Junction Train depot is set to continue this year with installation of decking and landscaping. The train depot is a great and unique addition to the park area. We are excited to be able to restore a piece of Glenwillow history.

The Recreation Committee has been busy planning the Summer Concert Series and other events for this year. Bring a blanket or chairs and enjoy music at Avery Lake every other Sunday from 5 p.m. to 7 p.m. throughout the summer. Below are the dates for the 2023 Summer Concert Season. Look for more information inside this newsletter for other events planned for this spring.

GLENWILLOW SCHOLARSHIP PROGRAM



The Village of Glenwillow is pleased to offer scholarships to our students who reside in Glenwillow and graduate from Solon Public Schools or Private Schools. This money is donated from companies who have opened businesses in the Village with the assistance of various tax incentives that we are authorized to offer. This money is set aside for the scholarship program created by the Mayor and Village Council many years ago. Each year, the Village and a representative from the Solon Schools review the tax incentives to ensure compliance with the program. Village Council established the scholarship program to help the youth of our community. Students who have graduated from High School while living in Glenwillow for at least one year will be awarded \$250.00 per year with the maximum amount of \$1,000.00. Students must attend a 2-year or 4-year accredited college or university in order to be eligible. Applications will be sent out in March to graduating seniors.

WHO OWNS WHAT? OWNERSHIP GUIDE FOR YOUR HOME'S ELECTRICAL SYSTEM

When your home's exterior electrical system is damaged, it's important to understand which components are our responsibility and which are yours. If you receive overhead electric service, we are responsible for the following components:

- 1. Service Drop The wires running from the utility pole to your home.
- 2. Electric Meter Measures your electricity use in kilowatt-hours.

You own and are responsible for repairing the following:

- 1. Weatherhead and Insulator This is the point where our electric lines connect to your home.
- **2. Service Entrance Cable** The wire that extends from your weatherhead to the meter and from the meter to your fuse box or circuit breaker box.
- 3. Meter Base Your meter is mounted in this box.
- **4. Fuse Box or Circuit Breaker Box –** This is the main service panel that houses your fuses or circuit breakers.
- **5. Household Wiring** The interior wiring that distributes electricity through your home. As a customer, it's also your responsibility to maintain open access to the meter and keep obstructions away from power lines that extend from the utility pole to your home. If trees on your property grow near power lines, don't prune or remove them yourself. Consult with a tree contractor who is qualified to work around electric equipment.

We all play an important part in making electricity safe and reliable. This fact sheet contains general ownership guidelines.



ACCEPTABLE HAZARDOUS WASTE ITEMS

- Oil or solvent-based paint, sealers, primers, or coatings (aerosols or liquids)
- Varnishes, polyurethanes, shellacs
- Paint thinner, mineral spirits, turpentine
- Pesticides, herbicides, fungicides
- Caustic household cleaners
- Pool chemicals
- Automotive fluids, motor oil, car batteries
- Adhesives, roof tar, driveway sealer
- Kerosene, gasoline, lighter fluid

NON-ACCEPTABLE HAZARDOUS WASTE ITEMS

- Latex paint
- Explosives, gun powder, ammunition, flares
- Medical waste, pharmaceuticals, medicine, sharps
- Radioactive waste (i.e. smoke detectors)
- Appliances, electronics
- Fluorescent bulbs

LICENSE PLATE RENEWAL

When you renew your license plates with the Ohio Bureau of Motor Vehicles, please remember to make sure you tell the clerk or indicate online, that you live in **GLENWILLOW.** (not Solon) The Village receives its portion of the license tax fee which is used to repair our roads. Since Glenwillow shares a zip code with Solon, many times the plates are registered incorrectly. There is no difference in the tax if you are listed with Solon or Glenwillow. Please help us earn the money for which we are entitled.



LOCAL INCOME TAX-FILING DEADLINE: APRIL 18TH, 2023



The Village of Glenwillow has a 2% income tax. All persons over 18 years of age working in the Village of Glenwillow and all business entities doing business in the Village are subject to the local income tax. Glenwillow residents are granted 100% credit up to 2%, for municipal tax withheld or paid to another municipality.


All residents over 18 years of age must file an annual return whether tax is owed or not. R.I.T.A. tax filing deadlines are the same as the Federal and State taxes-April 18, 2023.

NO SOLICITATION

The best way to keep solicitors and unwanted guests from knocking on your door is to display "No Soliciting "signs. By posting a sign, you are exercising your right to refuse uninvited visitors. Village code section 741.04 prohibits solicitation of any residence with a "No Soliciting" sign posted. The Village is currently partnered with NOPEC to participate in a No Solicitation program. You do not have to be NOPEC customer to participate in this program.

A FEW HOME MAINTENANCE TIPS FROM THE BUILDING DEPARTMENT

1. Check or install smoke detectors & CO detectors.

Take precautions to make sure that your home is safe. Your home should have a working smoke detector inside each sleeping area, outside the common area of the bedrooms and every level of the home, including the basement.

2. Maintain your kitchen and Appliances.

Spilled foods and liquids associated with cooking, prepping and serving meals can eventually do damage to surfaces and attract unwelcomed guests. Take some time and clean those hard-to-reach areas where these things tend to gather. Make sure that your dishwasher is properly functioning and nothing is leaking under the kitchen sink.

3. Clean Humid Areas

Your bathroom and shower areas, if not properly ventilated can cause all sorts of mold and mildew issues. Check your bathroom exhaust fans to make sure that they are working properly. If you do not have a bathroom exhaust fan, always open a window when using the shower. Check caulking around showers, bathtubs, sinks and toilet bases and make repairs when needed.

4. Walk through your entire property

Often times rarely used spaces in your home get ignored. Take some time once a month to do a walk through to check for leaks, insects, frost or other possible issues that cause damage to your home. The best defense to costly home repairs is a good offense.

5. Pay attention to your plumbing

Inspecting your plumbing system regularly should be an important part of your house maintenance. Do a visual inspection and look for signs of damage, leaks, corrosion or running water. If you spot any of these issues, consider proactively replacing the part or calling a professional for assistants.

6. Obtain permits when required

Typically, general maintenance work is not going to require involvement from the Village Building Department. However, if you are replacing a major appliance, installing a fence, or shed, or considering a small to large remodel. Its best to start with the Building Department to get an understanding on what process may be required for your project.

NO PARKING

There is **NO PARKING** on any residential street in the Village of Glenwillow. If you are having a party, work done on your home, a special event or having a large number of visitors, please contact the Police Department for parking permission. Once permission is granted, be sure to park on the side of the street opposite from the fire hydrants. Parking on both sides of the street is prohibited. Officers routinely patrol our residential streets. During patrols, officers closely monitor the streets for parking violations. Officers will enforce our Village parking ordinances by issuing a written warning to first time offenders, and citations to repeat offenders.



WHAT IS DISTRACTED DRIVING?

Distracted driving is any activity that diverts attention from driving, including talking or texting on your phone, eating and drinking, talking to people in your vehicle, fiddling with the stereo, entertainment or navigation system — anything that takes your attention away from the task of safe driving.

Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for 5 seconds. At 55 mph, that's like driving the length of an entire football field with your eyes closed.

You cannot drive safely unless the task of driving has your full attention. Any non-driving activity you engage in is a potential distraction and increases your risk of crashing.
