### **Public Hearing:**

Public Hearing to discuss potential projects within the Village of Glenwillow that would be applicable for funding through the Cuyahoga County 2024 Supplemental Grant Program. (project cost not to exceed \$50,000.00)

The Public Hearing opened at 7:01PM.

Engineer Mike Henry recapped the program. The County gives funding to communities who apply for funding for projects that are for the betterment of the community. The Village has been very successful, in the past, securing this grant. The money has been used for various projects such as; trails, playgrounds, the Veteran's Memorial, and train depot. This year there is a fiscal gap for the grant money of \$250,000 we have already received for the Cochran Road Phase II Project that will take place next year. The \$50,000, if we are able to secure it, will help with this project. This project consists of approximately 1,400 of roadway, from Pettibone Rd. to the railroad tracks.

### LAW DIRECTOR MARK MARONG:

Law Director Mark Marong commented; There are six proposed Ordinances that are changes to the Building Code. Items 2, 3,4 and 5 change the requirements of deposits and Building Department operations and are all on second reading. He asked item 3, 8 & 9 be tabled, and items 8 & 9 be referred to the Planning Commission and the Building and Housing committee meet to discuss.

Item 6 is an appropriation Ordinance.

Item 7 is adopting the Village codified Ordinances and the State of Ohio Traffic Code changes.

Items 10, 11 &12 are recapping the policies of programs offered to residents.

Items 13 & 14 are agreements with Gillmore Security for a security system and cameras at the new Municipal Service Center Complex.

Item 15 approves the new rates for medical benefits for the full-time employees from Summit County.

### ENGINEER MIKE HENRY:

Engineer Mike Henry reported; his report was submitted in the Mayor's report.

Installation of the pickleball courts has begun.

Larry Sylver questioned what constituted a change order for the project so early in its beginning stages. Mike Henry responded; originally the asphalt was to be bid separately and done next year. The contractor was able to get the asphalt this year and will be able to install it before the end of the year.

### **CHIEF GREG CURTIN:**

Chief Curtin reported; His reports were submitted in the Mayor's report.

The Chief held his annual meeting with the supervisors and full-time employees. He has finished his required 24 training and all other Officers have completed required training.

Officer Winans is also an active reservist in the Army. He has been called up for duty and will be leaving for Qatar in June for 1 year.

### **BUIDING OFFICAL BRADEN THOMAS:**

Building Official Braden Thomas reported; there are several items that pertain to the Building Department on the agenda. They have to deal with the operations of the department and look at the current deposits the Village requires. Discussions are taking place to require a fees instead.
