FINANCE DIRECTOR JOHN VERES:

Finance Director John Veres commented; the Finance Department is wrapping up the 2023-year finance reports. Once completed they will be prepared for the Hinckle System and the audit will begin.

LAW DIRECTOR MARK MARONG:

Law Director Mark Marong commented on the following agenda items:

The annual participation legislation to participate in selling unused items on Gov Deals.

Raising the number to allow the Police Department to have four Sergeants.

A motion to prepare plans and go out for bids for the Concrete and Asphalt Programs.

Two agreements; one with the Cleveland Restoration Society to enhance homes 50 years and older and the other is with NEORSD.

Accepting the NEC grant from NOPEC. Funds will be used to insulate the old service garage that the Police Department will be taking over as garage space for their vehicles.

Agreements with Solon Lighting and Twinsburg Youth Sports Academy for use of the soccer and baseball fields.

A right of entry agreement for improvements on Richmond Road across from Tryon.

Authorization to apply for a grant from the Ohio EPA Division of Surface Water H2Ohio Rivers initiative for a new salt storage facility.

ENGINEER MIKE HENRY:

The Engineering report was submitted it the Mayor's Report.

Authorization to bid Phase III of the Veterans Memorial is on the agenda for the installation. Most of the material has already been delivered.

We received funds collected by NEORSD from 12 residents on Richmond Road. They charge a fee, and the Village gets back 25% of what is collected on the Stormwater Fund. The funds will be used for street sweeping.

The Village applied for the OPWC Grant, and we are number one for small government. We will make improvements on Pettibone Road to the RR tracks. The Village has already received \$250,000 in ARPA funds and \$250,00 in County Maintenance funds.

The Village has been working with the Cleveland Metroparks to connect Hawthorn Parkway to Hawthorn Parkway. This will be a great addition to the Tinkers Creek Trail North.

The alignment was done on Richmond, Shepard, and Broadway Roads in 2013. Glenwillow, Twinsburg, Macedonia and Oakwood have all worked on the project together. Property acquisition is now done to finish the project. Relocation of utilities will be starting. Once completed there will be turning lanes to make the intersection safer.

BRADEN THOMAS CHIEF BUILIDNG OFFICIAL:

Chief Building Official Braden Thomas reported; there will be a spring newsletter going out introducing the residents to the new processes and the property maintenance and standards the Village has.

There is a Planning Commission meeting on February 21st with one item on the agenda along with appointing the Chairperson and the Secretary. There will be no ARB on February 21st. There will be Planning Commission and ARB meetings on March 20th. Custom Products submitted applications for fencing.

CHIEF GREG CURTIN:

Chief Curtin reported; His reports were submitted into the Mayor's report. The Village received reimbursement in the amount of \$10,697.04 for Law Enforcement Continuing Professional Training for 2023.

SERVICE DIRECTOR BOB GIRARDI:

Service Director Bob Girardi commented; the Service Department report was submitted in the Mayor's Report. He thanked Council and Staff who attended the walkthrough at the new Service Center. The department has been cleaning out the old Service and Building Department offices and the Annex building and pavilion.

The new fuel tanks are installed and fully functional.

ECONOMIC DEVELOPMENT DIRECTOR JEREMY ROWAN:

Economic Development Director Jeremy Rowan commented; his report was submitted into the Mayor's report. He provided an update on the Job Creation Grant Agreements. Invoices have been sent out to the five businesses with active agreements.

The State of Ohio changed the way CRAs work, how they are created and how they are reported. Starting this year they have done away with individual company reports and just have the area report. It will now be reported in aggregate. It is no longer that each business reports its own individual stats. It will be a one zone report. They will be due at the end of March.

The calculation for the school income tax sharing is \$285,000 this year. The Finance Department will be making the payment.

Jeremy talked to the County and the reappraisal that is taking place county wide is coming out to a 30% increase in home values. This will not equate to taxes due to HB 920.

The broker who is working with the owners of the TTI building has had a lot of showings. The lease with Spectrum goes through the middle of next year, so it is difficult for any business to make a purchase that far ahead. As the lease comes closer to an end, the more likely it will be to find a buyer.

The Cleveland Steel space is being marketed by JLL. There has been difficulty finding an interested party that likes the ratio of office to industrial space.

Southern Glazer's is in the mix since they are vacating one of their buildings here at the end of the year.

The building where Venture Lighting is also available.
