FINANCE DIRECTOR JOHN VERES:

Finance Director John Veres commented; The first amendment to the appropriations for the year is on the agenda for this evening.

The rollover of the bond notes for the Service Center is on the agenda, not to go over \$6.6 million. They are currently outstanding at \$6.9 million. At least \$300,000 will be paid toward the principal.

LAW DIRECTOR MARK MARONG:

Law Director Mark Marong gave an update on the CD&D proposed site expansion: Waste Management approached the Village a year ago indicating plans to potentially expand the site. The plan presented was to go north, down the hill into Solon towards Swagelok. It is not a large area. The Ohio EPA approved it and it is now before the Cuyahoga County Board of Health. The Engineer, Mike Henry, analyzed it with Waste Management, and from the site lines, the Village of Glenwillow should not see any activity. All portions of the site within Glenwillow will be closed off within the next year. Solon and Swagelok have no objections to the expansion.

Law Director Mark Marong commented on the agenda items:

Items 4 & 5 are the next phase in the train depot restoration. If approved this evening, the Village will donate to Midwest Railway Society, and they will complete a decking project around the depot.

Item 6 will be placed on first reading. The Village currently has a moratorium on adult use, growth, retail sale and distribution of medical marijuana. This is an amendment to the zoning code that would prohibit the growth, retail sale and distribution for recreational purposes. All communities that currently have a moratorium are passing something similar. This item will be referred to Panning Commission.

Items 7 & 8 were presented by the Mayors and Managers Association in conjunction with Cuyahoga County and dispatches. This is approving the county 911 plan and selecting Mayor Gail of Euclid as representative.

Item 9 is a right of entry agreement with the City of Solon to hard wire the flock camera they placed in the Village.

Items 10 & 11 are Engineering items; accepting the proposal of Specialized Construction for the 2024 Asphalt Program and approving the change order for R.E. Warner for the Service Center Project.

Item 12 is authorizing the purchase of a new Police Vehicle.

Items 13 & 14 are a motion to prepare plans for the Austin Powder Sewer Cleaning Project and authorization to advertise for bids.

Items 15, 16 & 17 are Engineering items. Approving a change order with Grade Line and accepting the proposals of Auburn Fence and Caroon Asphalt for work on the pickleball courts.

ENGINEER MIKE HENRY:

Engineer Mike Henry commented; the Engineering report was submitted it the Mayor's Report and commented;

The change order with Grade Line was for erosion issues on the Tinker's Creek Trail North.

The materials for the train depot deck project will be received by the end of May and installation will be this summer.

The fencing and striping of the pickleball courts will be completed in August.

Discussion took place regarding the Tinkers Creek Trail South. Engineering will monitor it for erosion and issues with the asphalt.

The trail at the Donald Norman Payne recreation Complex sits low near the playground. It was discussed to apply for a CDBG Grant to improve the drainage there.

Jeff Adie asked if the Engineer could look into placing a crossing on Pettibone to cross the street from Maplewood to the John Brown trail. Mike Henry stated he will look into it.

CHIEF GREG CURTIN:

Chief Curtin reported; His reports were submitted into the Mayor's report.

We have received the two new AEDs that were purchased. One will be installed at the new Service Center and the other at the restrooms at the DNP Recreation complex.

A safety meeting was held this evening before the Council. The committee discussed the purchase of a new vehicle. On the agenda is the purchase of a new 2023 Ford Explorer and is asking Council for passage. There have been issues with the Tahoes. One of them had to have the engine replaced (under warranty) and they both loose oil quickly.

The Flock Camera System has been installed. There are three cameras, two on Pettibone and one on Richmond. The one installed by the City of Solon is at Pettibone and Diamond Pkwy. There is a Right of Entry Agreement on the agenda with the City of Solon to hard wire it.

BRADEN THOMAS CHIEF BUILIDNG OFFICIAL:

Building Official Braden Thomas commented; he has submitted reports into the Mayor's report.

There is a Planning Commission meeting scheduled for May 15th. There will be a referral from Council for the Planning Commission and an ongoing property maintenance issue. There will be no ARB meeting due to lack of agenda.

SERVICE DIRECTOR BOB GIRARDI:

Service Director Bob Girardi commented; the Service Department report was submitted in the Mayor's Report.

The department is busy cleaning up the flower beds and getting ready to plant flowers.

The department cracked sealed all the residential streets. In the past, this has been contracted out. It was done in-house.

We do not need to order salt this year, but still need to purchase the 360 tons we are committed to.

The House-Hold Hazardous Wate collection will take place this Saturday 9AM to 1PM.

Matt Stuczynski from MAS Financial Advisory Services LLC commented on Ordinance 2024-5-12, the short-term bond anticipation notes the Village purchased. The notes are coming due in July. The Village has the option to renew the note and pay it down or roll it over. The legislation before Council this evening is to consider the renewal of the notes. The rates are slightly lower now between 3.85% - 4.05%. Matt recommended keeping an eye on our TIF revenues and the rates.
