**LAW DEPARTMENT MARK MARONG:**

- Mark Marong stated; under old business this evening is *enacting Chapter 911 "Use of Public Right-of-Way" under Part Nine – Streets, Utilities, and Public Services Code, Title One – Utilities*. This is on 3<sup>rd</sup> reading this evening and can be passed.
- Mark Marong asked that the Ordinance; *authorizing a Community Reinvestment Area Tax Abatement Agreement by and between the Village of Glenwillow, RSD Investments Ltd. and InterDesign* is on 3<sup>rd</sup> reading and can be passed this evening.

- Items #4 & #5 are amendments to the Planning and Zoning Code and can be passed this evening.
- Items #6 & #7 the proposed new zoning for PPN's 991-22-088 & 991-22-104; reverting these back to General Industrial District and can be passed this evening.
- Item #10 is an Easement & Nuisance Abatement Agreement with Pettibone Glen HOA for the maintenance of the retention basin.
- A few of the items this evening are annual contracts that can be passed; Summer Concerts, Baseball and Soccer contracts
- The authority to sell items no longer needed on Govdeals is on the agenda that also needs to be passed annually.
- Item #14 is the Scholarship Program reaffirming what the requirements are and the process is for Seniors graduating from High School to be eligible for funds given for attending a 2 or 4 year college after graduating.

**ENGINEER MIKE HENRY:**

- Engineer Mike Henry reported on Ordinances 2017-2-10 & 2017-2-11. These are two modifications to two existing chapters in our code. Every 5 years the permits for the Ohio EPA are renewed for Municipal Stormwater Inspection Discharge. Some of the changes are verbiage and definitions. The revisions are to meet the Ohio EPA permit requirements and provide additional information and clearer direction for design engineers who use the codes to design stormwater management and drainage systems.
- Resolution 2107-3-8 this evening is the Memorandum of Understanding with the Cuyahoga County Board of Health to provide Stormwater Services in 2017-2018.
- The bid for the Pergl Road Phase III project was given to S.E.T. They were the low bidder with the amount of \$295,033.00.
- Mike Henry requested a motion be made to go out for bids for the annual Concrete and Asphalt Programs for this year and motion to go out for bids for the trail design and specs.

**SERVICE DIRECTOR SAM SCAFFIDE:**

- Sam has begun scheduling the annual spring and summer programs such as the Free Mulch Program, Discounted Mulch Program with Savarino Brothers and the Community Gardens.
- The Household Hazardous Waste Day will be May 13<sup>th</sup> with collection being at the Service Garage this year.
- The Service Department assisted Oakwood with installing the bases for the cameras that will be placed at the round-a-bout.
- Sam is in the process of negotiating on a used chipper so the Village can continue the Free Chipping Program in house.
- Sam looked at the trees at a resident's home on North Village Lane that looked sick. He called an arborist and it seems as though the cicadas have hurt them.
- The Department is in the process of cleaning out the flower beds and also working on some inside projects of maintenance and painting.
- The Village still needs to order 600 more tons of salt to meet the agreement this year. Due to the mild winter we still have 900 tons stored in the salt barn. Sam has purchased concrete blocks to put in the vicinity of the salt barn store and will cover for the remainder of the salt that needs purchased.
- Jeff Adie questioned what the ballpark price figure is for a chipper. Sam stated; a used one is close to \$20,000.00 and a new one runs close to \$40,000.00. Jeff questioned the life span of a chipper. Sam stated; as long as it is serviced and maintained it will last a long time.
- Barb DiBacco asked Sam to elaborate on the cameras at the round-a-bout. Sam replied; there will be a camera on the Oakwood side and 1 on the Glenwillow side. Discussion of the cameras took place in the beginning of the project. Oakwood Village will be doing the monitoring.


