- Reminder; Mayor Cegelka will be out of town November 9th through the 19th.
- SGM update; the Village went through the process of negotiating a tax agreement for the proposed spec. building, approval processes of the ARB and Planning Commission Board, and working on an agreement with the schools. The information was sent out for signatures for final distribution and filing with the state. Mayor Cegelka received a call from a Broker, not involved in the deal, informing him that the deal was off, and that Bluescope was bailing out of the deal. None of the principles in the agreement responded to any questions or calls. There was no response from Geis or JLL on Friday. Mayor Cegelka was able to speak with someone from Geis, on Monday, who stated; he was 99% sure the deal is off. Those representing Bluescope got questioned as to why they want to build this building in Cleveland. The Geis Companies did not have the courtesy to call the village and let anyone here know. \$3,000.00 was paid up front for attorney's fees for drafting the agreement. The Mayor does not have a lot of information at this time, but will keep Council informed as he gets more.

FINANCE DIRECTOR JOHN VERES:

- John Veres reported; the renewal for the Risk Management Insurance for the Village is on the agenda this evening.
- The Appropriation Amendment on the agenda this evening is the interest added for the special assessment for Bond Street.
- Two TIF Ordinances are on the agenda this evening; Mantua Manufacturing and GED.

LAW DIRECTOR MARK MARONG:

- Mark Marong stated; at the next Council meeting there will be legislation to rescinding the approval for the CRA Agreement and the Revenue Sharing Agreement for the SGM project.
- Effective Monday October 30th, Councilman Johnson has resigned. Council will need to appoint a Vice Mayor for the remaining two months of this year. In January, the annual organizational meeting will be held and Council will then elect the new Vice mayor for 2018. Motion will need to be made this evening to elect a Vice Mayor to serve in November and December.

Motion by Jeff Adie seconded by Larry Sylver to elect Don Banas to serve as Vice Mayor for the remainder of Eric Johnson's term ending December 31, 2017.

With vice Mayor Johnson's resignation, the vacancy must be filled. The Charter states; any vacancy in Council, whether resulting from death, disqualification, removal, resignation, or otherwise, shall be filled by vote of a majority of the remaining members of Council, which may be made by motion. Council shall fill the vacancy within thirty (30) days from the date of the vacancy. If Council fails to fill the vacancy by a vote of a majority of the remaining members of Council, within the time limited, the vacancy shall be filled by appointment of the Mayor. The person who fills the vacancy shall serve for the unexpired portion of the term. The person filling the vacancy shall as of the date of the vacancy have been a resident of the Village for not less than two (2) consecutive years prior to said date, and as of said date reside in the ward in which the vacancy occurs, and in other respects have the qualifications for a councilman prescribed in this Charter. There is no further information in the Charter or the Code that gives any further guidance to Council as to how to go about that process. In 2014, Council established a process. Notification of the vacancy was sent to all in the ward, an interview process for those interested took place and ultimately an appointment process. With November 7th, being Election Day, someone will be elected to fill Vice Mayor Johnson's seat beginning 2018. This evening, Council can make a motion as to how they would like to fill the vacant seat. Council has until November 29th to appoint someone to fill the vacancy. Jeff Adie suggested; the candidate, not presently on Council, with the highest vote total shall be appointed to the vacant seat provided the Charter qualifications are met. However, if the count is close and certifying the votes goes beyond the 30 days, the Mayor shall make the appointment.

Motion by Jeff Adie seconded by Don Banas to appoint a candidate to the vacant Council seat as follows; the candidate, not presently on Council, with the highest vote shall be appointed to the vacant seat upon certification, however, if the count is close and certifying the votes goes beyond the 30 days, the Mayor shall make the appointment.

Mr. Armstrong could not attend the meeting tonight due to his work schedule.

POLICE CHIEF MICHAEL MEGYESI:

Police Chief Megyesi reported; all reports were submitted in the Mayor's report.

- On Halloween the officers on duty passed out 60 goodie bags during trick-or-treat.
- Chief Megyesi submitted to the Finance Department information stating; all officers completed 20 hours of mandatory training. The Village will receive a \$2,9560 reimbursement for this.
- Chief Megyesi applied for and received a grant in the amount of \$3,000.00 for new bullet proof vests. The average vest costs \$800.00.

BUILDING OFFICIAL BOB RODIC:

- Mantua Manufacturing; the walls and roof are complete.
- InterDesign; the project is nearly complete and will be ready for occupancy in December.
- The interior finish of the GED project is under construction.
- There will be few items for the next ARB and Planning Commission meetings; a shed on Tinkers Valley and a split rail Fence on Pergl.
- Last month at the ARB and Planning Commission meetings approval were granted for a three car attached garage on Pettibone Road and a lot split on Victory Parkway.
- The adoption of the new Ohio Code is now in effect for commercial construction. This is the first update since 20112.
- Gurvis Smith questioned if the ARB and Planning Commission members have discussed moving the meeting to the third Wednesday of the month starting the January 2018. Bob confirmed they have and all agreed.

ENGINEER MIKE HENRY:

- Engineer Mike Henry reported; A proposal from Mike's Electric is on the agenda this evening for electrical work to be done at the new Pettibone Road Park.
- The parking lot at the end of Bond Street has been completed.
