Jeff Adie questioned the status of the Pettibone Rd. Trail South and asked if it can be cleaned up while there is no foliage and not a lot of vegetation; there is debris along the trail. Mayor Cegelka responded; the Service Department and the Engineer will look at the trail and at what could be cleaned up along it. Mike Henry stated; to repair the trail, the asphalt will be removed in the affected areas and geo-webbing will be used to build the area back up. Geo-webbing is used to stabilize soil.

Barb DiBacco thanked The Mayor and Council for the thoughtful donation made to the Hospice of the Western Reserve.
